Note 1. :- The Colleges will have to pay the required fee by filling the prescribed bill voucher which they can get from affiliation branch after submitting their affiliation application.

- The original F.D.R. must be deposited along with affiliation form (As per resolution passed by BOI on 24/11/2017 point no. 8)
- The College will have to deposit endowment fund as per University regulations as mentioned below

3. The colleges not having College Education Department NOC for the year 2019 will not be able to submit their application for extension of affiliation for the year 2020-21 as per the decision of BOI held on 03.03.2020.
4. The cost of affiliation form will be Rs. 1650/- per affiliation form for the Academic Session 2020-21
5. For extension of provisional affiliation fee will be charged 50% amount as per above chart for B.A., B.Sc., B.Com. Pass/Hons Course, M.A., M.Sc. and M.Com. For other professional courses full fee will be charged.
6. Permanent Affiliated Colleges will deposit 20% of affiliation fee every year to the University and such colleges will be physically inspected after every four years. (as per the decision taken in the BOM held on 27-10-2018)
7. Affiliation fee for increase in intake of seats (one section) will be charged as per section wise *i.e.* Rs. 79,200/- per Section (60 Seats). In case of refund, 40% deduction will be made.
8. The colleges applying for fresh / increase in intake / additional subject / permanent affiliation are required to pay Inspection Fee of Rs. 16,500/- each as per BOI resolution no- P.3(13) /MSBU/BOI/2017/2685-93 dated 07-12-2017 as per the decision taken in the BOI held on 24-11-2017. The inspection fee of Rs. 16500/- will also be charged from all colleges. The re-inspection if required fee of Rs. 22,000/- with a penalty of Rs. 6600/-* (in case of refusal of inspection by the colleges as per the decision taken in BOI held on 24-11-2017) will also be charged.
9. The hard copy of application with required documents and prescribed fee will have to be deposited by the college in the University within the limit of given date.

Note 3. : This notification is subject to final decision of Hon'ble High Court of Rajasthan.

Note 4. : This notification is being issued in expectation to be passed in BOM.
