### Orders notified under s 12 (6) of the University Act

Admissions

Following decisions have been taken by the Vice Chancellor under powers vested in him under s 12(6) in relation to opening of new courses in the University, The rules/decisions are notified under section 12(6) of the Act.

1. The fee for LLM one year has been reduced as shown in Annex 1 Part A; now the overall fee would be Rs 65000/- for the whole year excluding Caution Money.
2. The new course of MA (psychology) and Geography in Bharatpur is kept open for admissions till 30 Sept 2017.
3. In case of needy students partial fee waiver to the maximum extent of 25% to men and 30% to women candidates with the previous approval of Vice Chancellor can be considered. In addition scholarship to the extent of Rs 2000/- per semester for MA and Rs 4000/- per semester may be sanctioned by VC on recommendation of OICs/teachers.
4. A few amendments have been made in LLM one year programme:
  - a) The nomenclature of LLM has been readjusted seeing the demands and preferences exercised by the students. Now the LLM would be available in three streams:
    - i) Criminal and Cyber Law
    - ii) Corporate and Intellectual Property Law
    - iii) Intellectual Property and Corporate LawThe last two streams presently similar in nature are being introduced to accommodate new courses within the stream after sanction of teaching posts with Government funds in second semester or next session.
  - b) The eligibility for LLM admissions has been reduced to 50% which is the normal percentage in most of the universities including University of Delhi and GGS IP university of Delhi.
  - c) Further on lines of relaxation in minimum eligibility in University of Rajasthan, it has been decided to give weight age of 1% for successful completion of PG Diploma in Law. If there arises any need of interpretation then the decision of VC in the matter would be final.
  - d) For admissions to LLM, in addition to CLAT an entrance or eligibility test for admissions has been opened. The fee for the application through local test was fixed at Rs 900/- equal to the CLAT candidates. The higher application fee paid by candidates would not be refunded.
  - e) The tuition fee has been reduced to Rs 50,000/-. The annual charges including fee for various specific purposes by the department has been brought down to Rs 15000/- (details shown in Annexure 1 Part B).
5. Vice Chancellor Prof Ashwani Kr Bansal who already agreed to supervise research shall also teach classes of LLM.
6. The remuneration payable to VC for teaching classes shall be diverted to **Needy Students Fund** which is established by this order. This fund would accept donations from others. The funds shall be spent on welfare of needy students or grants in addition to fee waiver, scholarships to students.

ii) Prof Ashwani Kr Bansal who has been Professor for more than 16 yrs and Head and Dean at Faculty of Law DU would be the Chairman of the BOS in Law w.e.f superannuation of present BOS Convenor on Aug 31, 2017 for 3 years from date of taking charge as BOS Chairman. This Order comes into effect at once on 9<sup>th</sup> Aug 2017.



In view of the fact that admission to two P.G. courses namely, M.A. Psychology and M.A. Geography are not upto the mark and the university wants to establish its five PG Courses from this year, the last date for university admissions in these courses is extended to 30 Sept 2017 and the total fee for both these courses is reduced to Rs. 12,220/- from now.
