Admission Policy in Self Finance Scheme (SFS) Courses of Residential Wing of MSB University

A. Rules for PG Admissions :-

1. Admission of a student to a course shall be subjected to the conditions prescribed by the University rules as applicable to the course in which admission is sought.
 2. Students shall not be eligible for admission to a course unless they have passed the qualifying examination or any other examination recognized for the purpose and possess such other qualifications (if any) as may be prescribed by the University rules.
 3. Applications for admission to various PG programs of study in the teaching departments of the University shall be submitted offline.
 4. Submission of application form does not guarantee admission.
 5. Admissions will be made on the basis of merit only (subject to the availability of seats in each category and fulfilment of the conditions laid down by the University for the purpose from time to time).
 6. All admissions will be provisional till the applicant completes all the formalities required.
 7. Candidates may note that any discrepancy regarding fee or eligibility criteria or any other alike due to printing or any other kind of error shall not provide any right to the candidates for admission to any particular course. The candidate shall be required to pay the actual fee applicable for the course at the time of admission.
 8. If the candidate is admitted to one course and wishes to seek admission to another course of the University, 75% fee deposited by him/her, can be adjusted in the later course in which he/she is finally admitted to.
 9. Any fee structure may be changed at any time as per the guidelines or norms of the Hon'ble Court/Government/University without any prior information or notice to the candidate and deposition of the same fee shall be binding upon the candidate.
 10. No student shall be treated as admitted to a course till he/she has deposited the necessary fees as per university rules.
 11. The deposited caution money will be refundable only after clearance of dues, if any, when claimed within three sessions of leaving the university.
 12. Refund of fees will be applicable as per UGC rules/State Govt. Norms.
- #### **13. Rules for Non-Rajasthan applicants:**
- a) Not more than 20% students shall be admitted from institutions outside Rajasthan. Such candidates should have secured a first division and should be otherwise eligible. However, the condition of obtaining a First Division may be relaxed in the case of,

- i. Female candidates migrating to Rajasthan on account of their marriage to a resident of Rajasthan.
 - ii. Male candidates, who after passing the qualifying examination from any other University, have passed a three-year course from this University, and
 - iii. Son/Daughter of a serving employee of the Central Government or a Public Sector Organization posted in Rajasthan. They will be considered for admission on the basis of merit at par with candidates from Rajasthan.
- b) Non-Rajasthan students securing a second division from other states may also be considered subject to the availability of seats after all the eligible students from Rajasthan and First Division holders from other states have been accommodated. The rule of minimum percentage wherever applicable, will however, be followed.
14. **Admission of candidate with a supplementary:** An applicant who is declared eligible to appear at the supplementary exams may be admitted provisionally at his/her own risk, if seats remain vacant on the last date fixed for admission. If seats are vacant at the time of first merit list, he/she may be admitted provisionally at the time of preparation of first merit list. For that purpose he/she will be assumed to have secured minimum pass marks in the subject of supplementary examination.
15. The candidate who have appeared in the qualifying examination, but the result is awaited, may also apply. However, they shall be required to submit the completion certificates/documents within the stipulated time.
16. **Non-eligibility:** The following categories of students shall not be eligible for admission:
 - i. Any candidate against whom an F.I.R. has been lodged by the University or any of the Constituent Colleges or any affiliated College or by any other competent Authority/ Officer of the University/ College shall not be eligible for admission as a regular candidate in any of the Departments of the University.
 - ii. Any person who has been convicted of criminal offence involving moral turpitude shall not be eligible for admission as a regular student in any of the Departments of the University.
 - iii. Any candidate who has been found guilty in any misbehavior with any teacher or with any authority/official of the University shall be debarred from seeking admission in any of the Departments of the University.
17. Reservation Policy –
 - 17.1 Reservation of seats/relaxation of marks for SC, ST, OBC, MBC, EWS candidates will be as per policy of State Government for above reservation. The Roaster System laid down by the State Government will be applicable.
 - (a). 49% of the total number of seats in each course will be reserved for NATURAL BORN sons/daughters of parents belonging to SC (16%), ST (12%), OBC except creamy layer (21%).
 - (b). 5% of the total number of seats in each course will be reserved for More Backward Class (MBC). As per policy of State Government, More Backward Class (MBC) is included in 21% reservation for OBC and this 5% reservation for MBC is in addition to 21% reservation for OBC.

- (c). 10% of the total no. of seats in each course will be reserved for economically weaker sections as per policy laid down by the State Government.
- (d). Candidates belonging to SC, ST, OBC, MBC and EWS category will be required to produce a certificate to that effect from a District Magistrate/Sub-Divisional Magistrate/Asstt. Collector/ Tehsildar without which their cases will not be considered as per directions of the State Government. Validity of such certificates will be as per rules laid down by State Government.
- (e). (i) All SC, ST, OBC & MBC Candidates who have passed the qualifying examination for admission to a course may be arranged in order of merit within the category to which they belong.
 (ii) Those who have secured marks up to the level at which the General Category students are admitted they should not be counted towards reserved quota at all and should be included in the general merit list of admissions.
- (f). In order to fill the reservation quota for SC, ST, OBC & MBC candidates, there should be no hesitation to go down, if necessary, to the pass percentage of the qualifying examination.
- (g). For EWS Candidates admissions will be conducted as per rule of State Government.
- (h). For Deaf/Dumb/Blind candidates, eligibility is minimum pass marks of qualifying examination.
- (i). For defence services/CAPF reservation and relaxations rules will be as per the policy laid down by State Government.
- (j) Weightage of marks will be given while preparing the merit list (if any) only if the candidate has secured the minimum percentage of marks prescribed for admission to the courses.
- (k) The concession of marks (if any) under various clauses of admission policy will be given to a candidate to his/her advantage under any one of the clauses and not under more than one clause.
- (l) Concessions for women candidates will be as per policy laid down by State Government.
- (m) All other concessions like Sports, Co-curricular Activities, Scouts/Guides/Rover Scouts/Ranger Guides, Mountaineering and Son/Daughter/Grand Son/Grand-Daughter of freedom fighter etc. will be given as per policy laid down by the State Government with prior approval of Hon'ble V.C.

17.2 –

- (a) 5% of the total number of seats in each category and each course will be reserved for Physically Handicapped Candidates as per horizontal reservation rules. Candidates claiming this concession shall be required to furnish a certificate in original from competent authority as per Raj. State Government Rules.
- (b) As per policy of State Government 3% additional marks will be given to physically handicapped candidates to fill their quota. This benefit is just to fill their quota not to get higher place in merit list.

17.3 –

- (a) 1% of the total number of seats in each course will be reserved for the wards of Kashmiri Migrants. Other rules for them will be as per policy laid down by the State Government.
- (b) As per policy of State Government 3% additional marks will be given to Kashmiri Migrants candidates to fill their quota. This benefit is just to fill their quota not to get higher place in merit list.

17.4 - Admission process for reserved category seats will be as per policy laid down by the State Government.

18. It is compulsory for all students to fill and deposit the “Group Insurance Form”.

19. Non-subject candidates who want to do their post-graduation in **the subject which was not studied by them at their Bachelor’s degree examination, will not be considered** for admission in any course.

20. A student migrating from a university shall not be admitted to any year of the course other than the first.

21. Transgender candidates will be admitted as per policy laid down by the State Government.

22. The University reserves the right not to conduct any self-financing courses if sufficient number of applications/ students is not available. In such cases the fee of the applicant shall be refunded.

23. All court cases shall be subject to jurisdiction of MSBU HQs at Bharatpur and not at any other place.
