CORRIGENDUM OF AFFILIATION NOTIFICATION

Session - 2025-26

The online process for submitting affiliation form for fresh colleges and affiliated colleges within the jurisdiction of Maharaja Surajmal Brij University, Bharatpur for the academic session 2025-26 is likely to commence from June 09, 2025. The college authorities may fill and submit their forms online by clicking the link given at the home page of University's official website i.e. msbrijuniversity.ac.in

Colleges will be able to submit application file in the University in hard copy after filling online application and depositing required fee. No hand written application forms will be accepted. The university would ensure that a fresh college desiring for new affiliation owns a valid NOC issued from the Commissioner/ Director of College Education Department of Rajasthan. Existing colleges will be allowed to deposit fee on the basis of affiliation order of session 2024-25 issued by this university. In case an affiliated existing college has not been issued affiliation order of the session 2024-25, may be considered to deposit fee on the basis of NOC of present session and of 2024-25 only after the permission of Hon'ble Vice-Chancellor. The following dates for submission of online affiliation form and affiliation fee of the affiliated colleges are as follows:-

Note:

The original F.D.R. must be deposited along with affiliation form (As per resolution passed by BOI on 24.11.2017 point no. 8).

2. A matured FDR shall be returned to the college only after submitting a new one amounting not less

than the same figure.

3. A new/fresh college which is granted affiliation based on the recommendation of inspection team and BOI shall be eligible for 120 seats in B.A. and 60 seats in B.Sc. and B.Com. courses. The college may apply for intake of more seats in next session only.

4. Fifty percent (50%) of basic fee (as per chart C) shall be charged for extension of provisional affiliation for existing colleges for B.A., B.Sc., B.Com. Pass / Hons. Courses, M.A., M.Sc. and M.Com. Full fee shall be

charged for other Courses.

- 5. Permanent affiliated colleges will deposit 20% + GST* of affiliation fee every year to the university and such colleges will be physically inspected after every four years (as per the decision taken in the BOM held on 27-102018).
- 6. Affiliation fee for increase in intake of seats will be charged Section wise i.e. Rs.1,07,900/- + GST* per Section (60 Seats). In case of refund applied by the college, 25% of fee and Processing fee deduction will be made as per decision of BOI
- 7. The colleges applying for fresh affiliation/ extension of provisional affiliation/ increase in intake/ additional subject/ permanent affiliation are required to pay Inspection Processing Fee of each as per decision taken by BOM held on 06.04.2021.
- 8. The College will itself pay Inspection Charges to the Inspectors (Rs. 2500/- each) along with T.A. & D.A.
- 9. Colleges are supposed to pay GST amount in view of the notices and summons sent to the University by the GST Department whichever is applicable on the total of fee as 18%. The point has been passed in Bol and BOM of the University respectively. The delay in deposition of GST shall incur penalty on GST amount as fixed by The GST department.

10. The University has increased the fee by 10% as per the orders of Hon'ble Governor and as per the directions of State Government.

- 11. The colleges applying for extension of affiliation will have to go for physical inspections as per the orders of Hon'ble High Court of Rajasthan, Bench at Jaipur in the case of S.B. Civil Writ Petition No. 6380/2024 Federation of Rajasthan Teacher Education Colleges, Jaipur Versus University of Rajasthan, Jaipur, State of Rajasthan Higher and Technical and Education Department Jaipur, Commissioner, College Education Rajasthan and PTET-2024.
- 12. University will not accept any amount deposited as Affiliation Fee transferred from an individual's bank account. Fee must be transferred from College's account only.
